Units were dispatched to 278 Roxboro Road for a disturbance. Upon arrival, I separated all parties involved to investigate the incident. After investigation, it was determined a male subject made threats of serious physical harm to another male and obstructed Officer's official business while on scene. The male subject was arrested, transported to VPD, and processed at VPD. An aggravated menacing and obstruction charge were constructed, and served to the arrested male subject. Several parties on scene claimed a fight broke out, injuries were reported, and was possibly captured on a construction crew members vehicle. Investigation ongoing.

I was dispatched to 278 Roxboro for a disturbance with a gun involved. Once on scene, the parties were separated. Myself, Ptl. K. Chandler and Ptl. Chrapczynski began to investigate the disturbance by gathering information. I first spoke with Mr. Schaal, a construction worker. Mr. Schaal stated he heard some commotion and looked down the street where a fight had broken out. He stated he went down there to break up the fight and he threw his shovel down before attempting to separate people. He stated he got knocked down somehow and fell awkwardly and jammed his hand into the ground. He showed me his hand which had swollen up significantly. He stated he did not know why the fight started. Pictures of his hand were taken at the scene.

I then spoke with Mr. Seeley, who stated he is the Job superintendent. He stated he arrived on scene immediately after the fight happened. He advised he got out of his truck and was trying to figure out what exactly happened. He stated, "the fat kid with red shorts" (later identified as William Bohland) looked at him and stated he was going inside to get his twenty gauge and shoot every fucking person out here. Mr. Seeley expressed his concern about keeping his crew safe while they finish the job. Mr. Seeley stated the semi driver that was parked in front of the Bohland residence has video of the incident and will get us the video as soon as he can. Mr. Seeley then transported Mr. Schaal to urgent care for treatment of his hand injury.

I then spoke with the neighbor across the street, Mr. Layberger, who advised Luke Bohland and William Bohland came out of their house "Running their mouths" to the construction workers. Mr. Layberger stated he went into the street and William came up to him and "swung". He stated he blocked the punch and returned a punch hitting William in self-defense. He stated they went to the ground and then the fight broke up. He stated his leg fell off during the struggle, Layberger has an amputated leg and uses a prosthetic leg, but he was okay. He stated William was yelling he was going to get his twenty gauge and shoot everyone in the face. I asked if there were any guns seen or involved, and he stated no.

While Ptl. K. Chandler and I were gathering information, it was learned that Mr. David Bohland (William and Luke's father) was on his way to the scene. He arrived on scene and was observed to be agitated and aggressive. He walked up to the two of us yelling and demanding we arrest the construction crew for hitting his son (Luke). We advised that we were still gathering information and that the incident was still under investigation. David then pointed at us, yelling that he was going to "handle this himself". He then turned toward the construction crew and

started to walk in their direction. I then went to stop David and prevent him from starting a confrontation with the construction crew while the investigation was taking place. William then stepped in front of me with his back toward me and his arms out wide, blocking my path towards David. I tried to go around William, and he moved his position and pushed back causing some resistance from me getting around him. I then pushed William in the back to move him away from in front of me. David then turned towards me and began screaming that I had just assaulted his son, making the scene that much more chaotic. William and David then demanded a supervisor to report to the scene. I then requested Det. Sgt. Holmes and Captain Graham to report to the scene. It was at this point we arrested William for Aggravated Menacing and Obstructing Official Business and removed him from the scene. Ptl. Chrapczynski transported William to the Vermilion Police station. David continued to rant and yell at me and the crew. Det. Sgt. Holmes arrived along with Captain Graham and were able to settled David down. I continued to get written statements from those we knew were involved along with witnesses not directly involved. I was then advised to report to the police department to assist Ptl. Chrapczynski with the arrestee.

I completed an affidavit for Obstructing Official Business (M2) for William Bohland for his actions at the scene in obstructing the investigation and hindering my duties in maintaining order at the scene.

On 04/22/25 at approximately 9:00 AM, Ptl. Chrapczynski, Det. Shupe, and myself responded to 278 Roxboro Road for the report of an active physical altercation between residents and a construction crew involving a shovel and a possible firearm. I originally attempted to drive North down Roxboro Rd. from Berkley Rd., but access was obstructed by multiple construction vehicles that were actively digging up the roadway. I then turned around and approached the residence from Edgewater Dr. Upon my arrival, I observed a red sedan (belonging to William Bohland) facing Northbound in the roadway in front of 278. There were approximately 20 construction workers on scene, most of whom were still working and running equipment.

I made contact with William Bohland and the caller, identified as Luke Bohland, in the front yard of 278. The following is a summary of William's sequence of events. William stated that the issues with the construction crew began yesterday when they parked a truck in a neighbor's driveway. The house was vacant at the time and William is friends with the owners. He advised the homeowner's have given William permission to park his own vehicle in the driveway. Yesterday, William approached the construction truck and advised them that they were not allowed to park there and they needed to move the vehicle. William stated that the worker then said that he would fill the driveway with rocks. That altercation ended there. Today, William stated that a construction truck was parked blocking his driveway, causing Luke to have to push their golf cart to the other side of the driveway in order to get his vehicle out. William then began to make comments to the driver of the construction truck. William stated that he told Luke they weren't allowed to block their driveway and they needed to move. William then stated that while walking across the street, he was next to the truck and yelled "Right they're supposed to move, right!". He then walked across the street to his vehicle that was parked in the neighbors driveway.

While walking, William stated that multiple workers began to shout at him and told him not to be a "Dick." William then got into his vehicle, pulled out of the driveway, and began driving Northbound on Roxboro Rd. His girlfriend, identified as Abigail Glass, was also in the vehicle. William stated that his neighbor, identified as Kirk Layberger, yelled toward the vehicle, "Take your hoe ass tramp to work!", to which William replied, "At least she has a job, you welfare recipient!". William stated that he then observed Kirk run up behind his vehicle. William got out of the vehicle and the two "Had some words". William stated he did not recall what exactly was said. He stated Kirk then punched him in his face, so William started "laying into him". He stated Kirk caused his glasses to fall off and get scratched. William stated that the construction workers made multiple threats to him. When asked what the threats were specifically he stated that he

did not remember. William also stated that he could not see well because he was pepper sprayed by Glass during this altercation. I was unable to get more details due to another verbal altercation that led to William being arrested.

Units were dispatched to 278 Roxboro Road for a menacing complaint. Upon my arrival, I was told there was a fight by a construction crew member. It should be noted that there is heavy construction going on at Roxboro Rd. I was pointed in the direction to the fight, and I observed three parties that I know reside at 278 Roxboro Rd. shouting at construction workers. They were Luke Bohland, William Bohland, and Abigail Glass. I separated all parties involved to investigate the incident. I inquired with Luke where the firearm is. Luke pointed at a male subject, later identified as Kirk Layberger, and stated he had it. Luke stated that Kirk had the firearm out on his property, and walked out into the street. Luke stated that Kirk threatened us. Kirk was near Luke and I and stated he was a liar. I continued the conversation with Luke near the previously mentioned residence.

I inquired with Luke on what happened. Luke stated he came outside of his residence to take William's girlfriend (Abigail) to work. Luke stated he was moving their golf cart because the construction crew was blocking their driveway. Luke stated he was pushing the golf cart out of the way because the battery was dead. Luke stated that his little brother (William) came out of the residence and walked across the street. I noticed injuries on Luke's face and asked if he was hit during the incident. Luke stated that he'd get to that part later. Luke stated he was pushing the golf cart because it was behind his vehicle. Luke stated that William walked up to him, and said that he was going to drive Abigail to work. Luke stated he didn't know that William was driving Abigail to work. While Luke was moving the golf cart, Luke heard William say "They shouldn't be blocking our driveway". Luke stated that approximately seven different guys and trailed off.

William walked over to Luke and I, and I noticed that William appeared to be in pain. I asked William what was wrong. William stated that he was accidentally sprayed with pepper spray by Abigail. William stated he was going inside the residence to rinse his face, and cleared the area. While I was waiting for William to be assisted in the residence by Abigail, I heard Det. Shupe radio to dispatch to send EMS to the area. Luke stated after William's comment to the construction crew, he heard the construction crew get "mouthy". Luke stated that William started to get loud. Luke told William to get in his vehicle. Luke stated that he heard his neighbor, Kirk, yell at William and threatened him. Luke stated that Kirk walked out with a gun. I asked Luke what firearm Kirk had out. Luke stated a rifle. I asked Luke if Kirk pointed the rifle at him. Luke stated no, but pointed the rifle at William and was walking close to William.

Luke stated they all (the approximately seven people mentioned earlier) surrounded William. Luke stated he told the people to stop surrounding William and to "fucking" go away. Luke stated that William backed out of the residence and started to travel northbound on Roxboro Rd. Luke stated that the seven people started to curse at William, and William stopped his vehicle. Luke stated that William said "What the fuck is your problem". Luke stated that William said "Move your fucking vehicles, and let us get the fuck out of here". Luke stated that the

seven people surrounded William. Luke stated that he observed Kirk put his hands on William. Luke stated that Kirk pushed and punched William. Luke stated that William punched Kirk. Luke stated that the construction crew "jumped" him and William. I asked Luke if Kirk punched first. Luke stated yes. Luke stated that he observed a construction crew member approach the altercation with William, and got involved.

Luke stated he punched a guy in the face and started to choke him out. I asked Luke if he knew who he choked out. Luke stated he didn't remember. Luke stated the fight started, and he told the VPD dispatch via his cell phone and dropped the phone. Luke stated he went over to the fight, punched a guy in the head, and pushed him back. Luke stated punched another guy and pushed him off of William. Luke pointed to the road in front of his residence, and stated he got dragged over southbound on Roxboro Rd. Luke stated he got struck on the head with a shovel, and told me to feel it. I could feel slight swelling on top of his head. Luke asked if EMS was enroute, and I advised they were. Luke stated he understood. Luke stated he was brawling with approximately two people and was hit with a flat squared shovel. I inquired with Luke if he threatened at any point to take any firearms out. Luke stated after Kirk had his gun out in the open, he threatened with his guns. I asked Luke if Kirk exited his property with his firearm. Luke stated yes, Kirk was standing in the middle of Roxboro Rd. with the firearm. Luke stated that Kirk told Luke that these people (construction crew) are my family, you (Luke) can't "fuck" with them.

Luke stated the he doesn't give a "shit", the construction crew is not moving because he was trying to leave the residence. Luke stated that's what happened before VPD arrived on scene. Luke stated that he's not going to lie, and had someone on the ground like this. Luke put his hand on his throat to show me what he did to the subject. Luke stated the unknown subject would not get off of him. William approached me and said he needed EMS for the pepper spray exposure. I advised William that EMS was enroute. I additionally advised William to keep running water on his eyes to flush the contamination. William cleared the area shortly after I advised William what to do. I asked Luke what kind of pepper spray was used. Luke stated he wasn't sure and moved William's vehicle on the property. While Luke was moving the vehicle, I approached Kirk to interview him

I asked Kirk if he had a firearm at any point during the incident. Kirk stated that his firearm has been laying on his car seat since yesterday. I asked Kirk if he pointed the firearm at anybody. Kirk stated no. Kirk stated if they (Bohland's) were going to bring a gun out, they (Bohland's) better have one on them. Kirk stated to the Bohland's if a gun was pulled out, he was going to drop them. Kirk stated that no one brandished a firearm. Kirk stated that it all started over a "stupid" golf cart. Kirk stated the construction crew has been on Roxboro Rd. since 8 AM. Kirk stated that Luke came outside the residence and started to run his mouth at the construction crew. Kirk stated Luke got into it (with the construction crew), and William got out of his vehicle. Kirk stated William swung at him and his artificial leg came off. Kirk stated William started to "pound" on him. I asked Kirk if he had any marks on him. Kirk stated he was not sure. I asked Kirk what happened today.

Kirk stated he was talking with someone in front of his residence (273 Roxboro Rd.), and saw Luke messing with the golf cart. Kirk stated he observed William running his mouth at the construction crew. Kirk stated that William tried to drive away in his vehicle, and was heading northbound on Roxboro Rd. Kirk stated he observed William stop the vehicle, and observed William running his mouth from his vehicle. Kirk told William not to block the road. Kirk stated that William looked mad, exited the vehicle, ripped his shirt off, and swung at him. Kirk stated he swung back. Kirk stated his punch connected with William. Kirk stated that William fell down, and William grabbed at his artificial leg. Kirk stated this happened right before William threatened to rip his artificial leg off and beat him with it. I asked Kirk who swung first. Kirk stated William swung first. Kirk stated he blocked William's punch, and swung back at William. Kirk stated that William got him to the ground, and William started to strike him in the head. Kirk stated that the construction crew got William off of him. Kirk stated none of this would have happened if Luke and William weren't running their mouths. Kirk stated he did not wish to press charges, but would if the Bohland's pursued charges. I had Kirk fill out a voluntary witness statement, and the statement matched what Kirk told me during the interview. While I was gathering information from Kirk, William approached me.

William stated he was not giving the construction crew their shovel back. I observed William walked away after that comment. I observed a male subject standing near Kirk, and I asked the male if he observed what happened. The male subject identified himself as Rory Layberger. Rory stated he is Kirk's brother, and saw what happened. I inquired with Rory on what he observed. Rory stated he was standing near 273 Roxboro Rd. during the incident. Rory stated he saw two guys exit 278 Roxboro Rd and walk towards the road. I asked Rory if it was the Bohland's that exited the residence. Rory stated yes. Rory stated it was all "hell" and high water, and there was fighting. I asked Rory if Kirk had his weapon out at any point during the incident. Rory stated no. Rory stated that all he knows is this started over one guy parking in the driveway. Rory stated that word's got exchanged, and the Bohland's started all of it. I asked Rory who he observed throw the first punch. I observed Rory point towards William, and Rory stated the heavier set boy did. Rory pointed towards Luke, and Rory said he did too. Rory stated the construction crew didn't do "shit", they were trying to do their job. I asked Rory again if he saw Kirk draw a weapon. Rory stated he didn't see "shit". Rory stated he just saw a fight. I had Rory complete a voluntary witness statement, and the statement matched what Rory told me during the interview. While I was interviewing Rory, Luke approached me and stated he was feeling faint. I observed Luke point at the construction crew, and Luke stated it's because of these "fucking niggers".

I advised Luke to knock it off and that EMS was already enroute. Luke stated no, he had the right to free speech. I observed Luke walk to his residence. The construction crew's Superintendent approached me, shortly after Luke cleared the area. The Superintendent identified himself as Victor Seeley. I asked Victor who was involved in this incident. Victor stated pretty much the entire crew. Victor stated his entire crew was assaulted. I asked Victor what he observed. Victor stated he showed up after the fight was broken up. Victor stated he did not know who swung first. I advised Victor that I needed to talk with Det. Shupe and Ptl. K. Chandler to see what information they gathered. While I was talking with Det. Shupe, a

construction worker approached us. The construction worker identified himself as David Woods Sr. David Sr. stated he observed the incident.

I asked David Sr. if he observed a weapon at any point of the incident. David Sr. stated no. David Sr. stated that Kirk is his cousin, and Kirk wouldn't do that. I asked David Sr. if he was the construction worker that Kirk was talking to. David Sr. stated yes. David Sr. stated they came outside and started to cuss. David Sr. said the one in the blue shirt was standing near the golf cart, and another one came outside with his girlfriend. David Sr. said the one that came out with his girlfriend started to yell at the truck driver. David Sr. stated to them that the construction crew can let them out anytime they want. I asked David Sr. who threw the first punch. David Sr. stated the guy in the red shorts. It should be noted that William was wearing red shorts, and Luke was wearing a blue shirt at the time of this incident. David Sr. stated that Kirk got hit first. David Sr. stated that Kirk punched back. I asked David Sr. who all was involved. David Sr. stated the two brothers (Luke and William), and the girl. I had David Sr. fill out a voluntary witness statement, and the statement matched with what was said in the interview. I asked David Sr. who on the construction crew was involved. David Sr. stated that David Woods Jr. observed the incident. I cleared the area to interview David Jr.

I asked David Jr. what he observed. David Jr. stated he was near a construction truck and observed a skinny one walking outside. David Jr. observed the skinny one moving a golf cart. David Jr. stated the skinny one said he was going to shoot a "mother fucker". David Jr. observed the skinny one point at the construction truck driver. David Jr. stated the skinny one said to move your "fucking" truck or he's going to shoot everybody. I asked David Jr. if the skinny one made the shooting comments first. David Jr. stated yes. David Jr. stated he observed the fat one walk outside. David Jr. stated he heard the fat one say that he has a shotgun, and is going to shoot everybody. David Jr. stated he heard the foreman ask the fat one if that was a threat. David Jr. stated he heard the fat one say you're damn right it is. David Jr. observed the fat one walk back into the residence.

David Jr. stated one of them came back outside, and enter their vehicle. The subject told the crew to move the "damn" machine. David Jr. told the operator that the vehicle had enough room. David Jr. heard the vehicle revving up repeatedly. David Jr. stated the vehicle moved, and stopped northbound on Roxboro Rd. David Jr. stated the subject jumped out of the vehicle, and started to attack another person. David Jr. stated the old guy was punched in the face, and started to fight back. David Jr. stated that himself and other crew members tried to break up the fight. David Jr. stated the fat one grabbed a shovel, and started to swing at everyone with the shovel. David Jr. stated the skinny one was trying to fight everybody. I asked David Jr. if any of his crew hit anyone with the shovel. David Jr. stated no, and crew member dropped the shovel to help defuse the fight. I advised David Jr. Luke was involved in the incident, and asked if anyone hit Luke in the head with a shovel. David Jr. stated no, if Luke was hit with a shovel Luke would be bleeding all over. David Jr. stated he heard Luke talking on the phone with police, and Luke stated the construction crew was threatening him. David Jr. stated they were the one's threatening to go in their house and grab a shotgun. David Jr. stated that they had no problems with anyone, and those guys threw a fit. David Jr. stated one of them had to move a

golf cart, and ends up threatening to shoot the construction truck driver. I asked David Jr. if he saw any of the construction crew hit William and Luke. David Jr. stated no. After my interview with David Jr., Det. Shupe approached me.

Det. Shupe advised me that Victor told him that a serious physical harm comment was said by William. Victor was told by William that he was going to grab his 20 gauge, and William said he was going to shoot all you "Motherfuckers". Det. Shupe advised me that we had enough arrest William for aggravated menacing. While Ptl. K. Chandler, Det. Shupe and I were gathering information it was learned that David Bohland was on his way to the scene. I observed David walk up to Det. Shupe and Ptl. K. Chandler and started yelling. I observed David turn toward the construction crew and started to walk in their direction. I observed Det. Shupe stop David. I observed William walk in front of Det. Shupe with his back towards Det. Shupe and William had his arms out wide. Det. Shupe tried to go around William, and William moved and pushed back. I observed Det. Shupe push William in the back to create space. It was at that point Det. Shupe and I arrested William for Aggravated Menacing and Obstruction of Official Business. I handcuffed William and advised William that he was under arrest. I checked for proper spacing and double locked the handcuffs. I escorted William to patrol cruiser #816, and I placed William in the back seat. I advised William of his Miranda Rights, and William stated he didn't understand. I asked William what he didn't understand. William stated he just didn't understand.

I transported William to VPD for processing. Upon enroute to VPD, William stated the pepper spray was irritating him. Upon my arrival, Officers at VPD rendered aid to William. Lifecare was called to VPD to render aid for William. Lifecare cleared the area after rendering aid to William. Booking Room photos were captured/logged, photos were captured/logged on William's injuries, and fingerprints were completed. An aggravated menacing and obstruction charge were constructed, and served to William. Vermilion Municipal Court was open today, and William later bonded out at Vermilion Municipal Court.

It should be noted, that Victor advised Officers on scene that video footage was possibly captured on a construction crew members vehicle. Victor stated that he was going to send the footage to VPD for further investigation of the incident. Victor had to leave the incident to assist one of his crew members, and was not served a Victims Rights Packet. Victor stated that he'd come to VPD to be served his Victims Rights Packet on 4-23-2024. This incident was captured on my department-issued body-camera.

Investigation ongoing.

While William Bohland was giving me his verbal statement of the incident, Luke Bohland would inject comments to his story. This is a summary of Luke's sequence of events. Luke stated that Kirk Layberger walked toward him in the roadway with a gun. He stated that he then said to Kirk "put your shit away. I'm about to get my gun if they don't stop". Kirk then walked away and put his gun in the garage. He stated at that time, a construction truck was blocking William's vehicle. At this time during the interview, EMS arrived on scene. Luke stated that he was hit in the head 4 or 5 times with a shovel and he felt like he was going to pass out. The interview was then paused so that Luke could be checked out by EMS. I observed a red mark on the left side of Luke's forehead. Before I was able to complete the interview, Luke decided to be taken to Mercy Hospital to be evaluated. He was advised to come to VPD when discharged to provide a written statement and get photos taken of his possible injuries.

Later, I reviewed the 911 call and Luke states that there are 5 construction workers walking up to him and one has a shovel. He is also heard saying "I'm about to shoot them. I feel threatened. They are coming on my property". He then states he saw a gun in someone's hand.

I spoke with William's girl friend, identified as Abigail Glass. Abigail stated that she did not observe much. She stated that she saw William exit his vehicle and heard Kirk running his mouth. She stated she then saw Luke on the ground and 4 or 5 men kicking him. She stated she saw a shovel get tossed into the yard, but did not see anyone get hit with it. Abigail stated she then retrieved pepper spray out of her bag and sprayed the group of males to break up the fight. VPD arrived on scene at that point. Abigail then got picked up, as she was already late for work. I dropped a Voluntary Witness Statement form off at her workplace and advised to return it to VPD.

All interviews were recorded on my body worn camera.

After EMS left the scene and all parties were mostly de-escalated, William's father (David Bohland) arrived on scene. David turned onto Roxboro Rd. from Berkley Rd., and parked his vehicle in the roadway right at the start of the construction zone. David then had to walk through the construction zone to make contact with us at 278 Roxboro. David appeared to be highly agitated from the moment he approached us. He met with myself, Det. Shupe, and William in the roadway in front of 278. William then pointed to a truck that was driving away and said that the male driving put his hands on him and he wanted to pursue charges, but we were letting him get away. David immediately said "I am going handle this my way then", he then turned around and began walking at a fast pace toward the construction site. Det. Shupe and I gave David verbal commands to turn around and stop walking toward the construction zone. Det. Shupe attempted to walk toward David, and William stepped in front of him with his back toward him and arms stretched out beside him, seemingly trying to block Det. Shupe from moving toward David. Det. Shupe then pushed William to move him out of the way. David then walked back over to us and he and William began to shout at Det. Shupe. William and David were both extremely close to Det. Shupe, yelling in his face. Due to multiple combatants, their size, and the aggression being portrayed, I unholstered my department-issued Taser and held it at low ready, in preparation to be used if necessary. At that time, Ptl. Chrapczynski arrived and I holstered my Taser. David and William then backed up and made distance between themselves and officers. Due to statements from the construction crew, Ptl. Chrapczynski then placed William under arrest for Aggravated Menacing. William was transported to VPD and had his court appearance at 2PM.

After William was transported, David moved his vehicle in front of his residence at 278 Roxboro. He drove erratically and revved his engine multiple times while doing so. David moved all of the vehicles at his residence and parked them directly on the line to the roadway in an apparent attempt to obstruct the construction crew. David then stayed outside of his residence and continued to argue with officers, construction workers, and neighbors. Captain Graham and Det. Sgt. Holmes arrived on scene shortly after. At one point, David made the comment to Det. Shupe, "I hope you get your fucking ass beat coming out of your house one day.. you're a piece of shit". Captain Graham was then able to de-escalate David. All officers then cleared the scene.

Per William's permission, I wrote out it out. William stated that early this morning he was taking Abigail Glass (William's girlfriend) to work. William stated he walked down his driveway (278 Roxboro Road), and noticed Luke Bohland (William's brother) pushing their golf cart down the other side of the driveway. William stated that he heard Luke venting about the construction crew bloacking their driveway. William stated that he walked down the driveway and raised his voice. William stated they should "fucking" move their vehicle. William stated they couldn't block them in their driveway. William stated he walked to his vehicle that was across the street. William stated that he heard the construction crew say that they should have asked them to move their vehicle.

William stated his sun roof was down when he was driving away, and honked at the construction crew to move their vehicle. William stated that he stepped outside of his vehicle, and noticed Kirk Layberger standing behind his vehicle. William stated that he heard Kirk shout at him about Abigail. William stated that Kirk told him to take his "whore ass cunt" to work. William stated that he told Kirk that at least his girlfriend is not a welfare recipient. William stated that Kirk close-hand punched him in the face after the comment. William stated he then close-fist punched Kirk repeatedly in Kirk's face and head. William stated it was a "haze" after that.

William stated the last thing he remembered was being on the ground after a construction worker tackled him to the ground. William stated they both exchanged punches, and he saw the construction worker run away. William stated that's when he notcied VPD arrive on scene. This statement was captured on the booking room camera.

The following is what's on Steven's statement. Steven stated that he observed loud noise and went to investigate. On 04/22/25 I was dispatched to the area of 278 Roxboro Rd. to assist Officers on the scene of a disturbance. Upon arrival I met with the Officers on scene and was given a brief summary of what had occurred. Capt. Graham and I then began speaking with David Bohland on scene. Bohland was highly agitated and verbally aggressive at the scene. Capt. Graham and I were eventually able to speak with Bohland and get him to calm down. During the course of this, I had to warn Bohland to choose his words carefully. Bohland had made the comment that he was going to have it out for Det. Shupe and that Det. Shupe was now a "target on his list". Bohland was warned for this statement and retracted what he had said and apologized because he understood that the statement could be interpreted as a threat. Bohland did eventually calm down and we were able to clear the scene. Bohland asked me what William was being charged with and I advised him of the Aggravated Menacing charge. Bohland asked me what that charge was for and I advised that William had allegedly threatened to retrieve a 20 gauge shotgun from the house and start shooting people. Bohland then stated that William could not do that because William had sold that 20 gauge to a cousin a month ago.

I then met with Luke Bohland at the VPD at approximately 2:15 PM. Luke had been transported from Roxboro to Mercy Hospital for treatment due to injuries he sustained during the incident. Luke provided a written statement and the following is a summary of that statement. Luke stated that William Bohland (brother) had to leave in his vehicle to take his girlfriend (Abby Glass) to work. Luke stated that the construction vehicles for Digioia Suburban Excavating, which is the construction crew hired by the City of Vermilion to complete the lateral sewer pipe replacement project in the VOL neighborhood, were blocking the roadway and driveway. Luke stated that William and one of the construction workers then began verbally arguing and Luke called 911. Luke stated that Kirk Layberger, who lives across the street from the Bohlands, came out from his property across the street and had a rifle. Luke stated that Kirk Layberger pointed the rifle at William and that the VPD Dispatcher told Luke to go into the house. It should be noted that William Bohland did not report a rifle being involved in the incident with Layberger.

Luke stated that he went back outside and saw that William had stopped his vehicle, with Glass as a passenger, in front of Layberger's house because Layberger was yelling comments at William and Abby. Luke stated that William got out of his car to confront Layberger about the comments and that Layberger then punched William in the face. Luke stated that William and Layberger then began fighting and that some of the construction crew members then began

fighting with William as well. Luke stated that he then went to the aid of his brother and tried to push some of the construction crew away from the fight. Luke stated that three construction workers then tackled Luke to the ground. Luke stated that he was able to get one of the construction workers into a "choke hold" and that another worker came up behind him and hit him in the head 4-5 times with the flat section of a metal construction shovel. Luke stated that during the fight, Abby exited the vehicle and pulled out a can of pepper spray that she carries and began spraying pepper spray into the group. Luke stated that a construction truck #3 was parked on the road where the incident took place. I asked Luke where he had been struck with the shovel and he stated that top center area of his head. I asked Luke if he had observed the subject who had struck him with the shovel and he stated that he did not. Luke stated that the subject with the shovel was behind him and he could not see him.

I then began documenting and photographing all of the injuries that Luke stated he received during the incident. I observed that Luke had some swelling and discoloration to the right lower lip area. I observed that Luke had some redness and scratches to left side of the forehead / hairline / eyebrow areas. Luke indicated that he had a small "bump" on the top of his head where he alleged that he was struck with the shovel, but also stated that the bump was starting to go away. I then observed a red scrape type of abrasion to the left torso area. This abrasion is approximately 3" long. I observed two vertical scratches to the center of Luke's back near the spine area. I observed a small scratch to the right lower hip area. I also observed several superficial scratches and abrasions to both lower legs. I did not observe any injuries to the arms or hands. I took photographs of all of the injuries with and without a ruler for scale.

Luke provided me with the Mercy Hospital Emergency Room discharge paperwork which I scanned and attached to the report. I also provided Luke with a Marcy's Law Victim's Rights packet.
